Dear Friends of Good Shepherd,

Though the pandemic is paramount in everyone's mind, there are many more stories and outcomes to celebrate in Good Shepherd's 2019-20 fiscal year. Each of you has done so much to support us during these unprecedented and challenging times, and we are so very grateful for your steadfast loyalty and generosity.

Despite the challenges of national disasters such as Hurricane Florence and the COVID-19 crisis, we are so proud to report that we had a record breaking year, returning 339 men, women and families with children from homelessness to permanent housing of their own. Our Case Managers have worked diligently to expand our network of landlords and steward existing relationships so that we have as many affordable housing units available to our guests as possible in a diminished environment. Your support has allowed us to provide rental assistance, utility deposits, intensive case management, food,

household items and furniture for our neighbors in housing crisis. Equally exciting is that 93% of those rehoused remained in stable housing six months later.

As many of you know, 2020 has brought along new challenges and we have had to postpone our spring events, including Empty Bowls; the 17th Annual Golf Tournament, Games Day, Tennis, Pickle Ball, Dinner and Auction at the County Club of Landfall; and our Kids Fest & Family Fun day. We are hopeful, at the time of this writing, that each of those fundraising events will take place in the fall, even if held in new and creative ways.

The COVID-19 crisis has created many wrinkles in our operations, but true to the Good Shepherd way, staff have rallied to continue to meet our mission *to feed the hungry, shelter the homeless and foster transition to housing*. We miss our many volunteers but are so grateful that you were able to stay healthy at home. We look forward to the day we can welcome back all 500 of you! Our heartfelt thanks to the many volunteers and donors who continued to support us during these difficult times with monetary and in-kind gifts. Please know that your dollars, hand sanitizer, homemade and store-bought masks, laundry detergent, coffee, and so much more from our wish list made our challenges easier to bear. Thanks to you, our guests continue to receive the supportive services they need to find their way back to housing.

We also salute our residents at the Sgt. Eugene Ashley Center and SECU Lakeside Reserve who, despite being especially vulnerable and at risk, rose to the challenge of social distancing, hand washing, and staying at home.

We hope the coming year will bring us all back together. In the meantime, our best wishes to our extended Good Shepherd family for another year of good health and great outcomes for our neighbors in crisis.

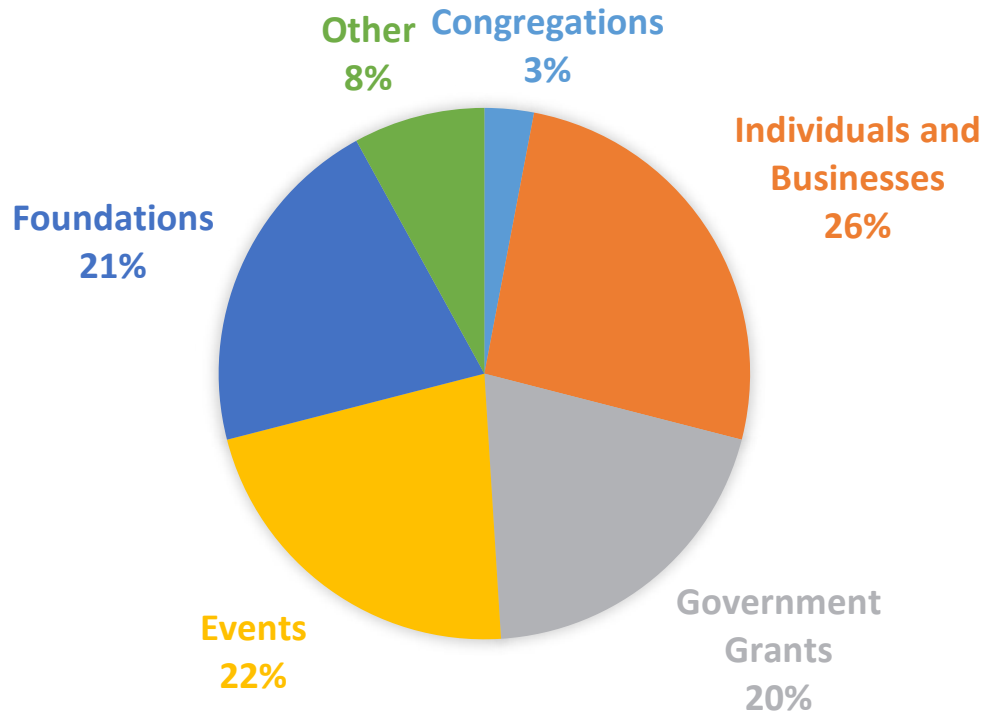

Good Shepherd Case Managers Joe and Deniell work day in and day out with our homeless neighbors in crisis. They never waver from their commitment to move some of our most challenged and vulnerable neighbors, including seniors, Veterans, persons with disabilities and families with young children from homelessness to permanent housing in our community.

On October 17, 2019 they were honored by the United Way of the Cape Fear Area during A Night of Heroes celebration, "dedicated to the men and women who make our community great."

We are so proud of Joe and Deniell, our unsung heroes.



## *Outcomes to Celebrate*

- A record breaking **339** men, women and families with children (over 60 kids) were returned to permanent housing this year;
- **93%** of those rehoused remained housed after six months;
- **120,000** hot and nutritious meals were served from our Soup Kitchen including breakfast, lunch and dinner;
- **160,000** food services were provided this year including meals, weekly food boxes to recently rehoused guests, bagged lunches for working shelter guests, and food give-aways to neighbors who came to Good Shepherd for lunch;
- Nearly **1 million** pounds of food was salvaged and redistributed to the hungry through our Second Helpings program. This food not only supports Good Shepherd's pantry and Soup Kitchen, but **16** other community programs that feed the elderly, children, persons with disabilities, and Veterans in New Hanover, Brunswick and Pender Counties;
- Over **1,200** visits were made by guests to our on-site Medical Clinic to see the nurse and/or doctor for wound care, prescriptions, and chronic condition diagnosis and treatment; and
- **56** Veterans were housed at the Sgt. Eugene Ashley Center, receiving supportive services and case management toward a plan to become rehoused.

## *Doing Good at the Sgt. Eugene Ashley Center*

We celebrate our many Veterans at the Ashley Center and thank them for their service.

This year we served **56** Veterans and moved **39** of them back to permanent and affordable housing of their own. Many of them are now our neighbors in this community, while others have moved on to Fayetteville and Jacksonville. We are proud to share a 92.8% success rate in placing our Bridge Housing participants into housing of their own. In keeping with

industry Best Practice, in 2017 the Ashley Center moved to the Bridge Housing model, a low barrier short-term housing program for homeless Veterans with the goal of transitioning them to permanent housing within an average of 90 days.



We are grateful to the many donors and supporters of our Veterans and share just one of the many stories of the lives you have touched.

Mr. M., an Army Veteran, has had five heart attacks. The last one sent him to the hospital, but because he was homeless, he was released to a recuperative care program to recover. That's where he learned about the Ashley Center. When Carolyn, Ashley Center's Case Manager called, "it was the best phone call I ever got," said Mr. M. After just two months in Bridge Housing, the program was able to assist him in moving to his own apartment on July 1. Remembering past days of living in his car, he is grateful for the peace of mind and stability that his new home provides. Mr. M. added, "The Ashley Center and the staff here are saviors for anyone that needs direction. They actually give you hope. Hope comes and goes on the streets. Here it's a constant."

## *SECU Lakeside Reserve*

SECU Lakeside Reserve celebrates four years since the first groundbreaking ceremony on August 19, 2016 when shovels met the dirt and construction began to turn a dream into reality.

Today, all 40 units of affordable housing for chronically homeless adults with a disability, including seniors and Veterans, are occupied. Some are original residents who moved in with the opening of Phase I and Abrams Hall. Others are more recent additions to the community, moving in with Phase II in June of 2019. Lakeside has been recognized as a thriving community by neighbors. Lakeside has also been the recipient of several awards, and most importantly recognized as a great place to live by the residents themselves.

# Covid-19 Response

~ As soon as the pandemic was made public and the at-risk population was deemed to be those 65 and older, we suspended volunteer recruitment and requested that our volunteers remain safe at home.

~ We converted our conference room to a “sick bay,” isolating any guests showing symptoms of flu, pneumonia, etc. A portion of the women’s dorm was also cordoned off for potentially infectious ladies with the flu.

~ We moved our lunch service for the greater community to a hot, to-go option, feeding our hungry neighbors from our front door.

~ When it was necessary to achieve greater social distancing, we suspended our food program to the greater community, focusing our meal efforts on providing solely for our homeless adults and children three meals a day.

~ At the end of March, we moved our women and families from the shelter to a local motel in order to decompress the shelter and spread the men throughout three dorms, the meeting room, and dining area. We continued to take new intakes of women and families and expanded the Healthy Motel program to include the immune-compromised adults and residents of the Salvation Army Shelter.







~ As a safety net for our neighbors in crisis, we continued to rehouse our homeless guests and moved 30 men, women and children, including three families, from shelter to housing in March.

~ From March 30 through June 1, 92 unduplicated homeless persons were served through the Healthy Motel program, including three pregnant women, one mother with cancer and more than 15 people who were living in a tent, their cars, or on the streets.

~ Our Case Managers provided supportive services, from transportation to essential appointments to delivery of toiletries and food boxes. Health Department nurses provided daily temperature and wellness checks for motel guests.

~ 30 people, including single moms and their children, families, couples, and individual men and women were rehoused directly from the motel to apartments of their own.

~ Our thanks to these partners in making the Healthy Motel effort possible: United Way of the Cape Fear Area, Salvation Army, nCino, and Live Oak Bank.

As of the writing of this report, we are continuing to monitor the situation and doing everything possible to keep our guests, staff and limited volunteers healthy and safe. We are beyond grateful to our loyal and new friends who have buoyed us through this crisis and continue to remind us that we are one Good Shepherd Family.

CONGRATULATIONS to Mr. B., the 339th shelter guest to be housed this fiscal year, moving from shelter to an apartment of his own on June 29. "I knew I was in good hands at Good Shepherd," Mr. B. said. "Safety first and they are serious about masks and keeping things clean," he added. "Good Shepherd clothed me, fed me, made me feel at home, warmed and welcomed. I had a dream about my own place and now it's come true."

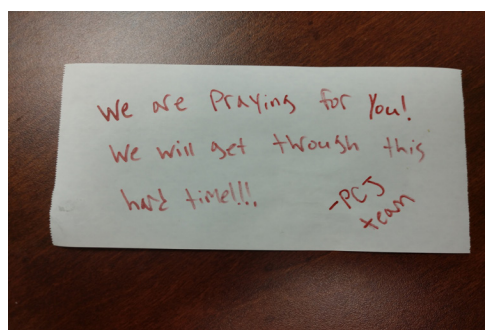

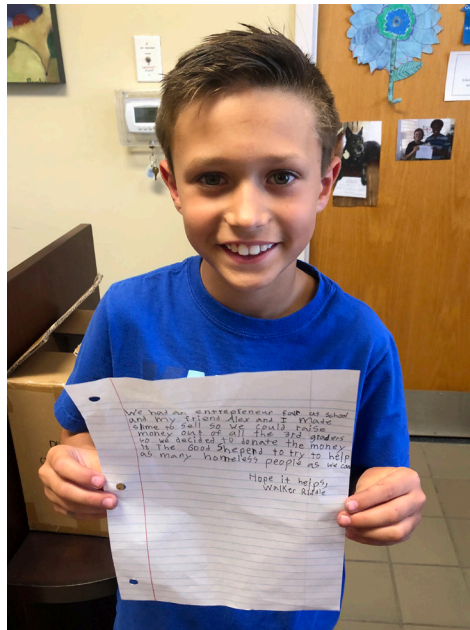
